

**CITY OF TORONTO**

**BY-LAW 552-2022**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Keele Street.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Keele Street	West	A point 60.5 metres north of Nashville Avenue and a point 67 metres south of Rotherham Avenue	8:30 a.m. to 6:00 p.m.
Keele Street	West	Eglinton Avenue West and Gilpin Avenue	7:00 a.m. to 9:00 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Keele Street	West	A point 60.5 metres north of Nashville Avenue and a point 31.1 metres further north	8:30 a.m. to 6:00 p.m.
Keele Street	West	A point 116.7 metres north of Nashville Avenue and a point 67 metres south of Rotherham Avenue	8:30 a.m. to 6:00 p.m.
Keele Street	West	Eglinton Avenue West and a point 116.7 metres north of Nashville Avenue	7:00 a.m. to 9:00 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

- C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Keele Street	West	A point 91.6 metres north of Nashville Avenue and a point 25.1 metres further north	Anytime

- D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Keele Street	West	Eglinton Avenue West (west intersection) and Gilpin Avenue	Anytime	2 hours

- E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Keele Street	West	Eglinton Avenue West and a point 116.7 metres north of Nashville Avenue	Anytime	2 hours

F. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Keele Street	West	A point 91.6 metres north of Nashville Avenue and a point 25.1 metres further north	8:00 a.m. to 6:00 p.m.
