BY-LAW 875-2022

To amend City of Toronto Municipal Code Chapter 910, Parking Machines and Meters, respecting Carlton Street and Queen Street East.

The Council of the City of Toronto enacts:

- Chapter 910, Parking Machines, is amended by adding the following in alphabetical order to Schedule II (Parking Machine Locations Designated as Electric Vehicle Charging Stations):

Carlton Street	North	A point 33.2 metres east of Bleecker Street and a point 6 metres further east	9:00 a.m. to 9:00 p.m., Mon. to Fri.; 8:00 a.m. to 9:00 p.m. Sat.; 1:00 p.m. to 9:00 p.m. Sun.	\$2.00 for 1 hour	3 hours
Queen Street East	North	A point 22.4 metres east of Northern Dancer Boulevard and a point 12 metres further east	9:00 a.m. to 9:00 p.m. Mon. to Fri.; 8:00 a.m. to 9:00 p.m. Sat.; 1:00 p.m. to 9:00 p.m. Sun.	\$2.00 for 1 hour	3 hours
