## CITY OF TORONTO

### BY-LAW 15-2023

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Forest Manor Road.**

Whereas North York Community Council on April 5, 2016 adopted Item NY13.28, wherein the report (March 8, 2016) from the Director, Transportation Services, North York District, recommended prohibiting parking at various locations on Forest Manor Road to be inserted into Schedule XIII (No Parking), of Toronto Municipal Code Chapter 950, Traffic and Parking;

Whereas North York Community Council on April 5, 2016 enacted By-law 323-2016, being a by-law " To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Forest Manor Road and Helen Lu Road", which by-law also inadvertently in some instances incorrectly referenced "Forest Manor Road" as "Forest Manor Drive";

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Forest Manor Drive	East	Helen Lu Road and Parkway Forest Drive (north intersection)	Anytime

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Forest Manor Drive	East	Parkway Forest Drive (south intersection) and a point 75 metres south of Helen Lu Road	Anytime
Forest Manor Drive	West	A point 65 metres south of Helen Lu Road and George Henry Boulevard	Anytime
Forest Manor Drive	West	Parkway Forest Drive (south intersection) and a point 65 metres south of Helen Lu Road	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Forest Manor Drive	West	Parkway Forest Drive (south intersection) and George Henry Boulevard	8:00 a.m. to 6:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Forest Manor Road	East	Helen Lu Road and Parkway Forest Drive (north intersection)	Anytime
Forest Manor Road	East	Parkway Forest Drive (south intersection) and a point 75 metres south of Helen Lu Road	Anytime
Forest Manor Road	West	A point 65 metres south of Helen Lu Road and George Henry Boulevard	Anytime
Forest Manor Road	West	Parkway Forest Drive (south intersection) and a point 65 metres south of Helen Lu Road	8:00 a.m. to 6:00 p.m., Mon. to Fri.
