## **CITY OF TORONTO**

### **BY-LAW 43-2023**

**To authorize the alteration of Hopedale Avenue, between Pape Avenue and O'Connor Drive, by the installation of speed humps.**

Whereas Toronto and East York Community Council deems it appropriate to undertake the installation of speed humps on Hopedale Avenue, between Pape Avenue and O'Connor Drive, and waived the polling requirements under the City's Traffic Calming Policy;

The Toronto and East York Community Council enacts:

1. The alteration of Hopedale Avenue, between Pape Avenue and O'Connor Drive, by the installation of seven speed humps, generally as shown on Drawing Nos. 421G-4013 and 421G-4014 dated April 2022 and 421G-4036 dated May 2022 attached to this By-law, is authorized.

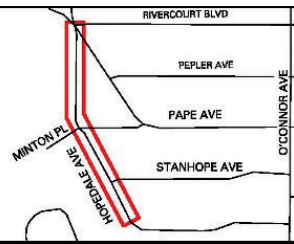

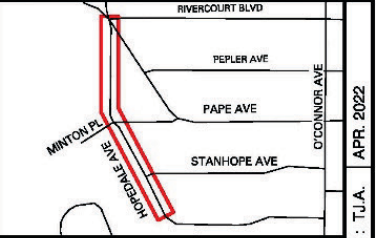

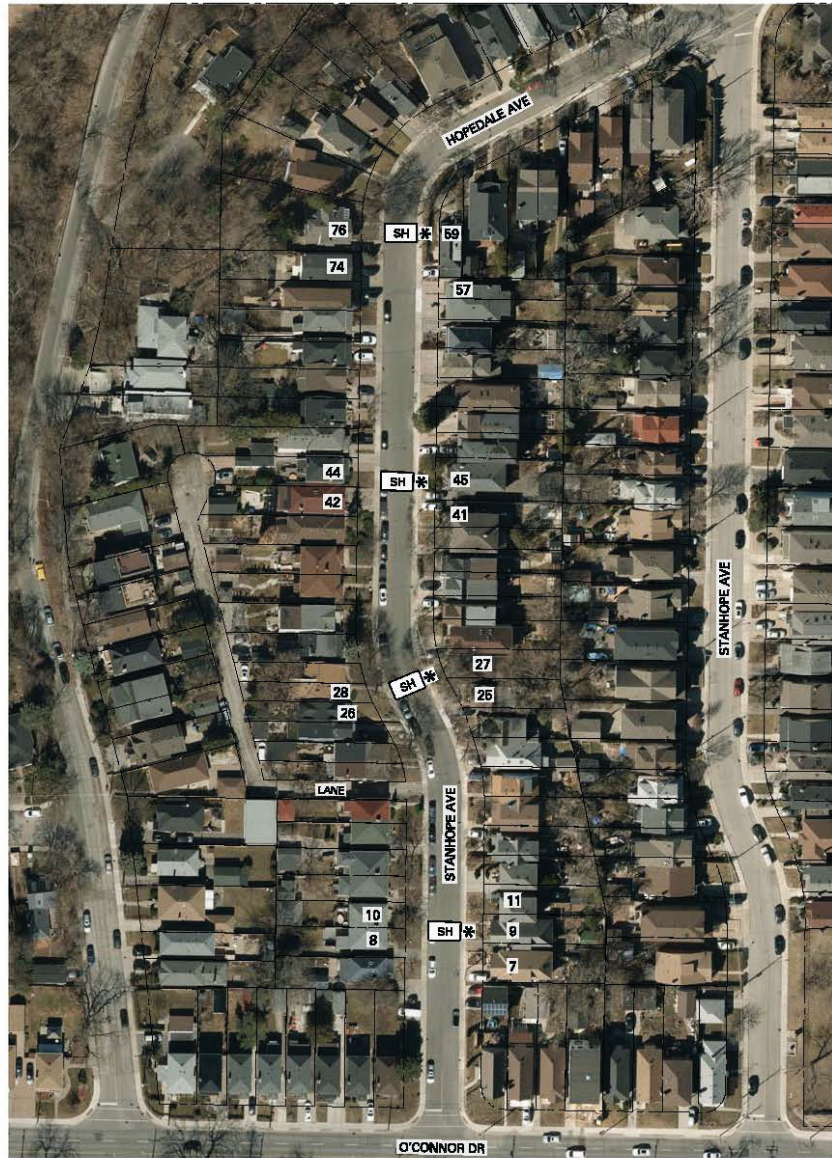
