CITY OF TORONTO

BY-LAW 50-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rushton Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rushton Road	West	A point 53.5 metres north of St. Clair Avenue West and Vaughan Road	From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Rushton Road	West	St. Clair Avenue West and a point 53.4 metres north of St. Clair Avenue West	Anytime
Rushton Road	West	A point 53.5 metres north of St. Clair Avenue West and Vaughan Road	Anytime, Dec. 1 to Mar. 31, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rushton Road	West	Charley Roach Lane and Vaughan Road	From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Rushton Road	West	Charley Roach Lane and Vaughan Road	Anytime, Dec. 1 to Mar. 31, inclusive

- C. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rushton Road	West	St. Clair Avenue West and Charley Roach Lane	Anytime

- D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Rushton Road	West	A point 53.5 metres north of St. Clair Avenue West and Maplewood Avenue	8:00 a.m. to 7:00 p.m., from the 16th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive	1 hour

- E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Rushton Road	West	Charley Roach Lane and Maplewood Avenue	8:00 a.m. to 7:00 p.m., from the 16th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive	1 hour
