BY-LAW 185-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Codsell Avenue and Tillplain Road.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Tillplain Road	West and south	A point 220 metres south of Waterloo Avenue and Cocksfield Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Tillplain Road	West and south	A point 126 metres south of Codsell Avenue and Cockfield Avenue.	8:00 a.m. to 4:00 p.m., Mon. to Fri.

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Tillplain Road	West	A point 15 metres north of Codsell Avenue to a point 83 metres south	8:00 a.m. and 6:00 p.m., Mon. to Fri.

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Tillplain Road	West	Codsell Avenue and a point 15 metres south of Waterloo Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.	10 mins.
Tillplain Road	East	A point 45 metres south of Codsell Avenue and Cocksfield Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Tillplain Road	West	A point 15 metres north of Codsell Avenue and Waterloo Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.	10 mins.
Tillplain Road	East	A point 126 metres south of Codsell Avenue and Cocksfield Avenue.	8:00 a.m. to 4:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Tillplain Road	The south side of Waterloo Avenue and the north side of Cocksfield Avenue

G. By inserting in Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

Tillplain Road	The south side of Waterloo Avenue and the north side of Codsell Avenue
Tillplain Road	The south side of Codsell Avenue and the north side of Cocksfield Avenue

I. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Tillplain Road	West	Codsell Avenue and a point 60 metres south	8:00 a.m. to 5:00 p.m., Mon. to Fri.
