## BY-LAW 188-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Avonwick Gate, Ballyronan Road, Bond Avenue, Brookbanks Drive, Carnforth Road, Castlegrove Boulevard, Charnwood Road, Dallimore Circle, David Dunlap Circle, Duncairn Road, Elvaston Drive, Evermede Drive, Greenland Road, Grenoble Drive, Hesketh Court, Humphrey Gate, Jessie Drive, Karen Road, Laurentide Drive, Mallow Road, Moccasin Trail, Ness Drive, Nob Lane, Ranchdale Crescent, Scarsdale Road, Slidell Crescent, Southwell Drive, Sundial Crescent, Sweeney Drive, Three Valleys Drive, Tremont Crescent, Wallingford Road, Wigmore Drive, Wyndcliff Crescent.

Whereas North York Community Council on May 24, 2022, in consideration of Item NY32.22, amended recommendation 1 in the report (May 5, 2022) from the Director, Project Design and Management, Transportation Services, to delete the words "and Ward 16" and adding the words "as it pertains to Ward 8 only"; and

Whereas on June 28, 2022 North York Community Council enacted By-Law 628-2022, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, with respect to the designation of Ward 8 (Area 1, Area 2, Area 3, Area 4, Area 5, Area 6, Area 7, Area 8, Area 9, Area 10, Area 11, Area 12, Area 13, Area 14) Boundary Area designated area and 30 kilometres per hour for public lanes and local roads within the designated area", which by-law inadvertently included entries for Ward 16 without the designated Community Council authority; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
