CITY OF TORONTO

BY-LAW 299-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Clarence Square and Wellington Street West.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following
in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Wellington Street West	North	A point 47 metres west of Bathurst and 22 metres further west	Anytime

B. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following
in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Wellington Street West	North	A point 42 metres west of Bathurst and 22 metres further west	Anytime

C. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following
in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Wellington Street West	North	Between a point 38 metres west of Blue Jays Way and a point 40 metres further west	Anytime

Clarence Square (east leg)	West	A point 11 metres south of Wellington Street West and a point 28 metres further south	9:00 p.m. of one day to 8:00 a.m. of the next following day
Clarence Square (north leg)	North	A point 31.5 metres east of Spadina Avenue (north intersection) and a point 61 metres further east	9:00 p.m. of one day to 8:00 a.m. of the next following day
Clarence Square (south leg)	North	A point 19 metres east of Spadina Avenue (south intersection) and a point 60 metres further east	9:00 p.m. of one day to 8:00 a.m. of the next following day
Wellington Street West	North	A point 39 metres east of Clarence Square and a point 53 metres west of Blue Jays Way	Anytime

Clarence Square (south leg)	North	Spadina Avenue (south intersection) and a point 19 metres further east	Anytime
Wellington Street West	North	A point 42 metres west of Bathurst and a point 27 metres further west	Anytime
