BY-LAW 368-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rhodes Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rhodes Avenue	East	The north end of Rhodes Avenue and the lane first north of Gerrard Street East	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive
Rhodes Avenue	West	A point 43.5 metres south of the north end of Rhodes Avenue and the lane first north of Gerrard Street east	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Rhodes Avenue	West	A point 268.2 metres north of Fairford Avenue and the lane first north of Gerrard Street East	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rhodes Avenue	East	Fairford Avenue and the north end of Rhodes Avenue	16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive

Rhodes Avenue	West	Fairford Avenue and a point 43.5 metres south of the north end of Rhodes Avenue	First day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive
Rhodes Avenue	West	Fairford Avenue and a point 268.2 metres further north	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Rhodes Avenue	East	Lane first north of Gerrard Street East and Fairford Avenue	Anytime, 1st day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive	1 hour
Rhodes Avenue	East	Lane first north of Gerrard Street East and Fairford Avenue	Anytime, Dec. 1 of one year to Mar. 31 of the next following year, inclusive	1 hour
Rhodes Avenue	West	Lane first north of Gerrard Street East and Fairford Avenue	Anytime, 16th day to the last day of each month, from Apr. 1 to Nov. 30, inclusive	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:
