BY-LAW 515-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Balliol Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule IX (Delivery Vehicle Parking Zones) in § 950-1308, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)	(In Column 5 Maximum Period Permitted)
Balliol Street	North	A point 17.7 metres east of Yonge Street and a point 19.1 metres further east	Anytime	20 mins.

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Balliol Street	North	Yonge Street and a point 93.3 metres east	Anytime
Balliol Street	South	Yonge Street and a point 185.5 metres west of Mount Pleasant Road (west intersection)	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Balliol Street	North	Yonge Street and a point 17.7 metres east	Anytime
Balliol Street	North	A point 36.8 east of Yonge Street and a point 56.5 metres further east	Anytime
Balliol Street	South	A point 105 metres east of Yonge Street and a point 185.5 metres west of Mount Pleasant Road (west intersection)	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Balliol Street	North	Yonge Street and a point 179.5 metres west of Mount Pleasant Road (west intersection)	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour
Balliol Street	North	A point 139.1 metres east of Yonge Street and Mount Pleasant Road (west intersection)	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Balliol Street	North	A point 139.1 metres east of Yonge Street and a point 179.5 metres west of Mount Pleasant Road (west intersection)	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Balliol Street	South	Yonge Street and a point 105 metres east	Anytime

G. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Balliol Street	South	Yonge Street and a point 23.5 metres east	Anytime
Balliol Street	South	A point 29 metres east of Yonge Street and a point 76 metres further east	Anytime
