BY-LAW 612-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting MacDonald Avenue and Pine Street.

Whereas Etobicoke York Community Council on June 6, 2018 adopted Item EY31.30, and authorized some entries for MacDonald Avenue and Pine Street to be rescinded and some to be inserted into Chapter 950, Traffic and Parking; and

Whereas, pursuant to Item EY31.30, Etobicoke York Community Council enacted By-law 674-2018, being a by-law "To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting MacDonald Avenue and Pine Street.", which By-law inadvertently included additional entries that deleted and inserted parking regulations on Pine Street without the designated Community Council authority and inadvertently failed to include entries in the By-law for approved Recommendations 3 and 6-10; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312 the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Pine Street	West	Lawrence Avenue West and MacDonald Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Pine Street	West	Lawrence Avenue West and a point 67 metres south of William Street	Anytime
Pine Street	West	MacDonald Avenue and a point 51 metres south of William Street	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
MacDonald Avenue	North	Springmount Avenue and Ralph Street	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Pine Street	West	A point 51 metres south of William Street and a point 63 metres further south	8:00 a.m. to 5:00 p.m.
Pine Street	West	William Street and a point 51 metres south of William Street	Anytime

D. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336 the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Pine Street	West	A point 51 metres south of William Street and a point 63 metres further south	8:00 a.m. to 5:00 p.m.
