BY-LAW 650-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Avonlea Boulevard, Chisholm Avenue, Dentonia Park Avenue, Eastdale Avenue, Lumsden Avenue, Maryland Boulevard, Palmer Avenue, Secord Avenue and Sibley Avenue.

The Toronto and East York Community Council enacts:
