BY-LAW 712-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Driftwood Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Driftwood Avenue	East	A point opposite the northerly limit of Yorkwoods Gate and Finch Avenue West	7:00 a.m. to 7:00 p.m., Mon. to Sat.
Driftwood Avenue	West	Finch Avenue West and a point opposite the northerly limit of Futura Drive	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Driftwood Avenue	East	A point opposite the northerly limit of Yorkwoods Gate and London Green Court	7:00 a.m. to 7:00 p.m., Mon. to Sat.
Driftwood Avenue	East	Yewtree Boulevard and Finch Avenue West	7:00 a.m. to 7:00 p.m., Mon. to Sat.

Driftwood Avenue	Both	Yewtree Boulevard and London Green Court	Anytime
