CITY OF TORONTO

BY-LAW 778-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Mossom Road, South Kingsway and The Kingsway.

The Council of the City of Toronto enacts:

- 1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mossom Road	West	Riverside Drive and a point 32 metres north	Anytime
