CITY OF TORONTO

BY-LAW 860-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brandon Avenue, Crawford Street, Eastwood Road, Huntley Street and Logan Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Crawford Street	Both	Sully Crescent and College Street	Anytime
Crawford Street	East	Dundas Street West and Barton Avenue	Anytime
