BY-LAW 1088-2023

To dedicate certain lands along Cherry Street, located between Lake Shore Boulevard East and the southerly limit of the Keating Channel, and New Cherry Street, located between southerly limit of the Keating Channel and Commissioners Street, for public highway purposes.

Whereas as part of the Port Lands Flood Protection and Enabling Infrastructure Project, part of Cherry Street is being realigned to the west of its current location; and

Whereas a new bridge has been constructed, carrying the realigned Cherry Street over the Keating Channel; and

Whereas arrangements are being made for the acquisition by the City in fee simple of most of the lands involved in the realignment; and

Whereas the Toronto Port Authority ("PortsToronto") owns a portion of the lands over which the new Cherry Street bridges are located with sections of the realignment created by infilling small portions of Ports Toronto owned waterlots in the Keating Channel and inner harbour (formerly known as Essroc Quay), and an easement is expected to be transferred from PortsToronto, authorizing the use of the lands as a public highway pending the anticipated transfer of the lands to the City in fee simple, which is subject to approval of the Minister of Transport;
