## **CITY OF TORONTO**

### **BY-LAW 1090-2023**

#### **To authorize the naming of a proposed public street, located between Lake Shore Boulevard and Keating Channel, as Cherry Street.**

Whereas the Council of the City of Toronto has the authority to pass a by-law naming the public street; and

Whereas the Council of the City of Toronto intends to provide an interim name to the street that will be replaced by a permanent name at a future date;

The Council of the City of Toronto enacts:

named Cherry Street.

2. Section 1 of this By-law shall take effect on the date that Section 1 of By-law 1088-2023 is in effect.

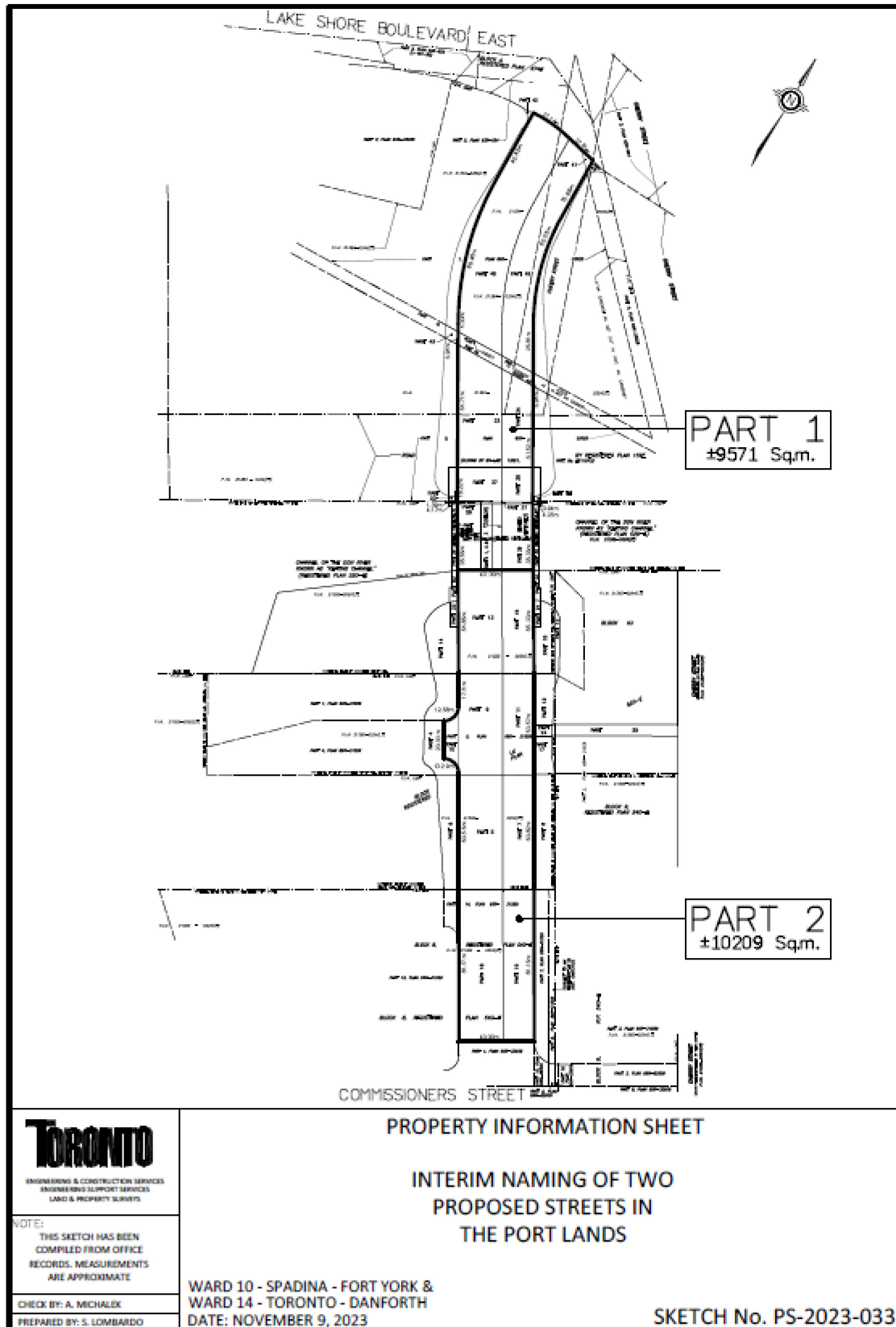
