CITY OF TORONTO

BY-LAW 1092-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Cherry Street, Cherry Street diversion road and Polson Street.

The Council of The City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
