BY-LAW 1094-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Commissioners Street, Saulters Street South and Villiers Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Villiers Street	South	Munition Street and a point 36 metres west	Anytime
Villiers Street (north branch)	North	Don Roadway and a point 30 metres west	Anytime
