**CITY OF TORONTO**

**BY-LAW 1097-2023**

**To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, respecting Cherry Street, Commissioners Street and Saulter Street South.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes, and Cycle Tracks, is amended as follows:

A. By inserting in Schedule E (Cycle Tracks) the following in alphabetical order by street name:

| Commissioners Street  | Saulter Street South and Carlaw Avenue                                  | Northerly Westbound  | Anytime                     |
| Commissioners Street  | Saulter Street South and Carlaw Avenue                                  | Southerly Eastbound  | Anytime                     |
| Saulter Street South  | Villiers Street and Commissioners Street                                | Westerly northbound lane adjacent to the westerly southbound cycle track | Anytime                     |
