CITY OF TORONTO

BY-LAW 1099-2023

To amend City of Toronto Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes and Cycle Tracks, and Chapter 950, Traffic and Parking, respecting Cherry Street, Commissioners Street, Don Roadway and Munition Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 886, Footpaths, Pedestrian Ways, Bicycle Paths, Bicycle Lanes, and Cycle Tracks, is amended as follows:

A. By inserting in Schedule E (Cycle Tracks) the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times or Days)
Commissioners Street	Cherry Street and point 176 metres east of Don Roadway	Northerly westbound and southerly eastbound	Anytime

2. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Commissioners Street	North	Between a point 94 metres east of Cherry Street and a point 20.5 metres further east	Anytime

Cherry Street and Commissioners Street (east intersection)	Southbound	Right	When traffic control signal shows red

I. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Access driveway on Commissioners Street, located on the south side of Commissioners Street at a point approximately 68 metres east of Munition Street	Westbound	Left	Anytime
Commissioners Street and entrance to River Park North	Eastbound	Right	Anytime

J. By inserting in Schedule XXIV (Compulsory Turns) in § 950-1323, the following in alphabetical order by street name:

(In Column 1 Highway Being Entered)	(In Column 2 Highway from which Vehicle Enters)	(In Column 3 Highway Not To Be Entered)
Don Roadway	Commissioners Street, eastbound, left lane	Commissioners Street, east of

K. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Commissioners Street	Cherry Street (east intersection) and the west end of Commissioners Street	40

L. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:
