## CITY OF TORONTO

### BY-LAW 1175-2023

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Divadale Drive, Glenvale Boulevard, McRae Drive, Moore Avenue and Winsloe Avenue.**

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XII (Permitted Angle Parking) in § 950-1311, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)
McRae Drive	Northeast	A point 15 metres north of Millwood Road and a point 15 metres south of Field Avenue
McRae Drive	South	A point 15 metres east Randolph Road and a point 56.5 metres further east
McRae Drive	South	A point 15 metres west and a point 47 metres west of Randolph Road
McRae Drive	South	A point 15 metres west of Sutherland Drive and a point 28 metres further west
McRae Drive	Southeast	A point 15 metres north of Millwood Road and a point 23 metres south of Rumsey Road

- B. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Glenvale Boulevard	North	Hanna Road and Brentcliffe Road	10:00 a.m. to 6:00 p.m., Mon. to Fri., except public holidays	1 hour
Glenvale Boulevard	South	Hanna Road and Brentcliffe Road	10:00 a.m. to 6:00 p.m., Mon. to Fri., except public holidays	1 hour

- C. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Divadale Drive and Winsloe Avenue	Winsloe Avenue

- D. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Moore Avenue	Bayview Avenue and Pottery Road	40
Moore Avenue	Pottery Road and Southvale Drive	40

- E. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Moore Avenue	Bayview Avenue and Pottery Road	30
Moore Avenue	Pottery Road and Southvale Drive	30
