CITY OF TORONTO

BY-LAW 1184-2023

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Vanley Crescent.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Vanley Crescent	North, west and south	Chesswood Drive (south intersection) and Chesswood Drive (north intersection)	Anytime
Vanley Crescent	East	Chesswood Drive (north intersection) and a point 170 metres south	Anytime
Vanley Crescent	South	A point 50 metres east of Chesswood Drive (south intersection) and a point 40 metres east	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Vanley Crescent	East	Chesswood Drive (north intersection) and a point 170 metres south	Sat. and Sun.

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Vanley Crescent	North, West and South	Chesswood Drive (south intersection) and a point 295 metres north	Anytime
Vanley Crescent	North, West and South	Chesswood Drive (north intersection) and a point 130 metres east	Anytime
Vanley Crescent	South	A point 50 metres east of Chesswood Drive (south intersection) and a point 40 metres east	Sat. and Sun.
Vanley Crescent	South and West	A point 130 metres east of Chesswood Drive (north intersection) and a point 160 metres further south	Sat. and Sun.

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Vanley Crescent	South, East and North	A point 50 metres east of Chesswood Drive (south intersection) and Chesswood Drive (north intersection)	Mon. to Fri.
Vanley Crescent	South and West	A point 130 metres east of Chesswood Drive (north intersection) and a point 160 metres further south	Mon. to Fri.

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Vanley Crescent	South	A point 92 metres east of Chesswood Drive (south intersection) and a point 170 metres south of Chesswood Drive (north intersection)	Anytime	1 hour
