BY-LAW 1203-2023

To authorize the naming of public lane located north of Bloor Street West, extending between Margueretta Street and Brock Avenue, as Michelle Senayah Lane.

Whereas pursuant to Section 27-18.4E(4) of City of Toronto Municipal Code Chapter 27, Council Procedures, Toronto and East York Community Council has the authority to pass a by-law naming the public lane;
