## **CITY OF TORONTO**

### **BY-LAW 90-2024**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting  
St. Clair Avenue West.**

The Council of the City of Toronto enacts:

**1.** Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

**A.** By deleting from Schedule XIII (No Parking) in § 950-1312, the following in  
alphabetical order by street name:
