### BY-LAW 148-2024

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Jane Street.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
