BY-LAW 277-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Annette Street, Dupont Street, Jane Street, Oriole Parkway, St. Clair Avenue West and Woodbine Avenue.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)	(From Column 5 Maximum Period Permitted)
Annette Street	North	Jane Street and Willard Avenue(west intersection)	9:00 a.m. to 9:00 p.m., Mon. to Fri.	2 hours
Annette Street	South	Willard Avenue and Windermere Avenue	9:00 a.m. to 9:00 p.m., Mon. to Fri.	2 hours
Dupont Street	North	A point 41 metres east of Edwin Avenue and a point 46 metres west of Symington Avenue	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour
Jane Street	East	A point 49 metres south of Hanley Street and a point opposite the south limit of Lessard Avenue	9:00 a.m. to 9:00 p.m.	2 hours
Oriole Parkway	West	A point 60 metres south of Eglinton Avenue West and a point 19 metres north of College View Avenue	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour
