## **CITY OF TORONTO**

### **BY-LAW 447-2024**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dane Avenue and Via Bagnato.**

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
