BY-LAW 468-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Deauville Lane, Eglinton Avenue East off-ramp to Ferrand Drive, Ferrand Drive, Rochefort Drive, Seton Park Road and Windom Road.
