CITY OF TORONTO

BY-LAW 489-2024

To amend City of Toronto Municipal Code Chapter 354, Apartment Buildings, and City of Toronto Municipal Code Chapter 441, Fees and Charges, with respect to updating notification board and record-keeping requirements and authorizing targeted engagement visits for apartment buildings.

The Council of the City of Toronto enacts:

- 1. City of Toronto Municipal Code Chapter 354, Apartment Buildings, is amended by:
 - a. adding the words "in a manner that ensures each piece of information is completely visible to tenants" to § 354-3.2.B so that it now reads as follows:
 - B. The following information shall be posted on the notification board in a manner that ensures each piece of information is completely visible to tenants:
 - b. deleting § 354-3.11.
 - c. adding a new subsection (d) to § 354-4.1.B(5) so that it now reads as follows:
 - (5) logs of all pest treatment activities, including:
 - (a) the date and location of treatment;
 - (b) the name of the pest management operator or exterminator licensed by the Ministry of the Environment undertaking the treatment;
 - (c) the nature of the treatment; and
 - (d) the date of a follow-up inspection, if any.
 - d. adding the words "to conduct targeted engagement visits in apartment buildings" and "and the owner or operator shall pay any fees in accordance with Chapter 441, Fees and Charges" to §354-5.1.B so that it now reads as follows:
 - B. The Executive Director is authorized to audit apartment buildings that require further investigation, to re-inspect apartment buildings to confirm that the owners or operators are complying with any issued orders, to

conduct targeted engagement visits in apartment buildings, and to take any other action necessary and authorized by law, and the owner or operator shall pay any fees in accordance with Chapter 441, Fees and Charges.

- 2. City of Toronto Municipal Code Chapter 441, Fees and Charges, is amended by:
 - a. Deleting the following from Appendix C Schedule 12, Municipal Licensing and Standards:
