BY-LAW 649-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Strathmore Boulevard.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Strathmore Boulevard	North	Between a point 15 metres west of Donlands Avenue and a point 7 metres further west	1	7:00 p.m. of one day to 7:00 a.m. of the next following day

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Strathmore Boulevard	North	Dewhurst Boulevard and a point 45 metres west of Donlands Avenue	Anytime
Strathmore Boulevard	North	Donlands Avenue and Greenwood Avenue	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Strathmore Boulevard	North	Dewhurst Boulevard and Greenwood Avenue	Anytime

D. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Strathmore Boulevard	North	Donlands Avenue and point 45 metres west	Anytime
Strathmore Boulevard	South	Donlands Avenue and a point 52 metres west	Anytime

E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)	(From Column 5 Maximum Period Permitted)
Strathmore Boulevard	South	Dewhurst Boulevard and a point 52 metres west of Donlands Avenue	10:00 a.m. to 6:00 p.m.	1 hour

F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Strathmore Boulevard	South	Dewhurst Boulevard and Donlands Avenue	10:00 a.m. to 6:00 p.m.	1 hour
