BY-LAW 722-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bunty Lane and Windham Drive.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Bunty Lane	West	Palomino Crescent (north intersection) and Palomino Crescent (south intersection)	9:00 a.m. to 3:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Bunty Lane	West	Palomino Crescent (north intersection) and Palomino Crescent (south intersection)	9:30 a.m. to 3:00 p.m., Mon. to Fri.
Windham Drive	South	A point 89 metres east of Bunty Lane and a point 128 metres further east	Anytime

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Bunty Lane	East	A point 45 metres south of Windham Drive (north intersection) and a point 190 metres south of Windham Drive (north intersection).	9:00 a.m. to 6:00 p.m., Mon. to Fri.
Bunty Lane	West	Palomino Crescent (north intersection) and Palomino Crescent (south intersection)	7:00 a.m. to 9:00 a.m., Mon. to Fri.
Windham Drive	South	A point 89 metres east of Bunty Lane and a point 128 metres east of Bunty Lane	Anytime

- D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Bunty Lane	West	Palomino Crescent (north intersection) and Palomino Crescent (south intersection)	7:00 a.m. to 9:30 a.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri.

- E. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Bunty Lane	East	A point 45 metres south of Windham Drive and a point 190 metres south of Windham Drive	7:00 a.m. to 9:00 a.m., Mon. to Fri.	15 mins.

F. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Bunty Lane	East	A point 45 metres south of Windham Drive and a point 52.5 metres further south	7:00 a.m. to 9:30 a.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.
Bunty Lane	East	A point 127.5 metres south of Windham Drive and Palomino Crescent (south intersection)	7:00 a.m. to 9:30 a.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.
