BY-LAW 758-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Thirty First Street.

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Thirty First Street	West	Lake Shore Boulevard and Birchlea Crescent	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Thirty First Street	West	Lake Shore Boulevard and a point 70 metres south.	Anytime
Thirty First Street	West	A point 6 metres south of Ash Crescent and a point 77 metres further south	5:00 p.m. of one day to 8:00 a.m. the next following day, Mon. to Fri.
Thirty First Street	West	A point 83 metres south of Ash Crescent and Birchlea Crescent	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Thirty First Street	Both	A point 76 metres south of Lake Shore Boulevard West and a point 116 metres south thereof	8:00 a.m. to 5:00 p.m., Mon. to Fri.

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Thirty First Street	East	Ash Crescent and a point 103 metres south	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Thirty First Street	West	A point 70 metres south of Lake Shore Boulevard West and a point 40 metres further south	Anytime

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Thirty First Street	West	A point 31 metres south of Ash Crescent and a point 52 metres further south	8:00 a.m. to 5:00 p.m., Mon. to Fri.	10 mins.

F. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Thirty First Street	West	A point 82 metres south of Ash Crescent and a point 30 metres further south	8:00 a.m. to 5:00 p.m.

G. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Thirty First Street	West	A point 6 metres south of Ash Crescent and a point 25 metres further south	8:00 a.m. to 5:00 p.m.
