BY-LAW 845-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dufferin Street, Jameson Avenue and Springhurst Avenue.

For further clarity, where any regulation contained in Subsection 1A to 1E, inclusive, of By-law 845-2024 conflicts with any other regulation in any Schedule of the Municipal Code Chapter 950, Traffic and Parking, the regulation as found in By-law 845-2024 shall prevail during the time frame outlined in the regulation as found in By-law 845-2024."
