BY-LAW 1129-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Boulton Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Boulton Avenue	West	A point 84 metres south of Dundas Street East and a point 41.5 metres further south	8:30 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive, for a maximum period of 10 mins.

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Boulton Avenue	West	A point 84 metres south of Dundas Street East and a point 41.5 metres further south	9:00 a.m. to 3:00 p.m., Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive

Boulton Avenue	West	A point 36.9 metres north of Clark Street and a point 125.5 metres south of Dundas Street East	10:00 a.m. to 10:00 p.m., Mon. to Sat.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Boulton Avenue	West	A point 58.5 metres south of Dundas Street East and a point 25.5 metres further south	8:30 a.m. to 9:00 a.m., 2:30 p.m. to 3:00 p.m., Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive, except public holidays	10 mins.
Boulton Avenue	West	A point 36.9 metres north of Clark Street and a point 84 metres south of Dundas Street East	10:00 a.m. to 10:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Boulton Avenue	West	A point 30.5 metres south of Dundas Street East and a point 53.5 metres further south	8:30 a.m. to 4:00 p.m. Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive

G. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Boulton Avenue	West	A point 30.5 metres south of Dundas Street East and a point 28 metres further south	8:30 a.m. to 4:00 p.m. Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive, except public holidays
