## **CITY OF TORONTO**

### **BY-LAW 1148-2024**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bond Street.**

The Toronto and East York Community Council enacts:

**1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:**

**A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:**
