BY-LAW 1157-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Widmer Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Widmer Street	West	Between a point 15 metres south of Adelaide Street West and a point 18.5 metres further south	Anytime
Widmer Street	West	Between a point 53.6 metres north of King Street West and a point 15 metres further north	Anytime

B. By inserting in Schedule X (Bus Loading Zones) in § 950-1309, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Widmer Street	West	Between King Street West and a point 42 metres north	Anytime

- C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Widmer Street	East	A point 43 metres north of King Street West and Adelaide Street West	Anytime

- D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Widmer Street	East	A point 33 metres north of King Street West and a point 39 metres south of Adelaide Street West	Anytime

- E. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Widmer Street	East	Adelaide Street West and a point 15 metres south	Anytime

- F. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Widmer Street	West	King Street West and Adelaide Street West	8:00 a.m. to 6:00 p.m.	1 hour

G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Widmer Street	East	A point 15 metres south of Adelaide Street West and a point 24 metres further south	Anytime
