CITY OF TORONTO

BY-LAW 1280-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Botfield Avenue and Mattice Avenue.

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in
alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mattice Avenue	North	Botfield Avenue (east intersection) and Jopling Avenue North	8:00 a.m. to 5:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical
order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mattice Avenue	North	A point 30 metres west of Botfield Avenue (east intersection) and a point 63 metres east of Jopling Avenue North	8:00 a.m. to 5:00 p.m., Mon. to Fri.

- C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mattice Avenue	North	Botfield Avenue (east intersection) and Jopling Avenue North	8:00 a.m. to 5:00 p.m., Mon. to Sat.

- D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mattice Avenue	North	Botfield Avenue (east intersection) and a point 30 meters west	Anytime

- E. By deleting from Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Mattice Avenue	The west side of Kipling Avenue and the east side of Jopling Avenue

- F. By inserting in Schedule XXVI (Through Highways) in § 950-1325, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)
Mattice Avenue	The west side of Kipling Avenue and the east side of Botfield Avenue (east intersection)
Mattice Avenue	The west side of Botfield Avenue (west intersection) and the east side of Jopling Avenue

- G. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Botfield Avenue and Mattice Avenue	Botfield Avenue
Mattice Avenue and Botfield Avenue	Mattice Avenue

- F. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Mattice Avenue	North	A point 20 meters west of Botfield Avenue (east intersection) and a point 33 meters further west	8:00 a.m. to 5:00 p.m.

- G. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Mattice Avenue	North	A point 63 meters east of Jopling Avenue North and a point 15 metres east of Jopling Avenue North	8:00 a.m. to 5:00 p.m.
