BY-LAW 1293-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Avondale Avenue.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Avondale Avenue	Both	Tradewind Avenue and Willowdale Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Avondale Avenue	South	Harrison Garden Boulevard and Oakburn Crescent	7:00 a.m. to 6:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Avondale Avenue	North	Tradewind Avenue and Willowdale Avenue	8:00 a.m. to 6:00 p.m., Mon. to Fri.
Avondale Avenue	South	Harrison Garden Boulevard and Oakburn Crescent (west intersection)	7:00 a.m. to 6:00 p.m., Mon. to Fri.
Avondale Avenue	South	Oakburn Crescent (east intersection) and Willowdale Avenue	9:00 a.m. to 2:30 p.m. and 3:30 p.m. to 6:00 p.m., Mon. to Fri.

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Avondale Avenue	South	Oakburn Crescent (west intersection) and Oakburn Crescent (east intersection)	8:00 a.m. to 6:00 p.m., Mon. to Fri.

C. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Avondale Avenue	South	Oakburn Crescent (east intersection) and Willowdale Avenue	8:00 a.m. to 9:00 a.m. and 2:30 p.m. to 3:30 p.m., Mon. to Fri.	15 mins.
