CITY OF TORONTO

BY-LAW 1298-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Abell Street, Bellevue Avenue, Borden Street, Gibson Avenue, Hazelton Avenue, Homewood Avenue and Lisgar Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Abell Street	East	A point 50 metres south of Queen Street West and Sudbury Street	Anytime
Lisgar Street	West	Sudbury Street and Queen Street West	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Abell Street	East	Sudbury Street and a point 20.5 metres north	Anytime
Lisgar Street	West	Sudbury Street and a point 20.5 metres north	Anytime
Lisgar Street	West	Queen Street West and a point 55 metres south	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Bellevue Avenue	West	Wales Avenue and Oxford Street	8:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour
Borden Street	West	A point 35 metres south of Bagpipe Lane and a point 66 metres north of Harbord Street	Anytime	1 hour
Gibson Avenue (TO)	South	Yonge Street and the west end of Gibson Avenue	10:00 a.m. to 6:00 p.m.	1 hour
Hazelton Avenue	East	A point 65.5 metres north of Scollard Street and a point 49.5 metres south of Davenport Road	8:00 a.m. to 6:00 p.m.	1 hour
Homewood Avenue	East	Carlton Street and Wellesley Street East	8:00 a.m. to 6:00 p.m.	1 hour
