BY-LAW 1310-2024

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dreamers Way, Nicholas Avenue, Oak Street, Pashler Avenue, Regent Street, Sackville Street, Tubman Avenue and Wyatt Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
