## CITY OF TORONTO

### BY-LAW 29-2025

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Austin Terrace.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Austin Terrace	North	Hilton Avenue and Lyndhurst Avenue	Anytime, from the 16th day to the last day of each month, Apr. 1 to Nov. 30, inclusive; Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Austin Terrace	North	Lyndhurst Avenue and Walmer Road	Anytime
Austin Terrace	South	Austin Crescent and Lyndhurst Court	Anytime, from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Austin Terrace	South	Walmer Road and Lyndhurst Court	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Austin Terrace	North	Hilton Avenue and a point 64 meters west of Lyndhurst Avenue	Anytime, from the 16th day to the last day of each month, Apr. 1 to Nov. 30, inclusive; Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Austin Terrace	North	A point 64 meters west of Lyndhurst Avenue and a point 69 metres east of Lyndhurst Avenue	Anytime
Austin Terrace	South	Hilton Avenue and a point 53 meters west of Lyndhurst Avenue	Anytime, from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Austin Terrace	South	A point 74 metres east of Lyndhurst Court and a point 53 metres west of Lyndhurst Court	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Austin Terrace	North	Austin Crescent (south intersection) and Lyndhurst Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri., from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive	1 hour
Austin Terrace	South	Austin Crescent and Lyndhurst Court	8:00 a.m. to 4:00 p.m., Mon. to Fri., from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive and from Dec. 1 of one year to Mar. 31 of the next following year	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Austin Terrace	North	Austin Crescent (south intersection) and a point 64 meters west of Lyndhurst Avenue	8:00 a.m. to 4:00 p.m., Mon. to Fri., from the 1st day to the 15th day of each month, Apr. 1 to Nov. 30, inclusive	1 hour
Austin Terrace	South	Austin Crescent and a point 53 meters west of Lyndhurst Court	8:00 a.m. to 4:00 p.m., Mon. to Fri., from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive and from Dec. 1 of one year to Mar. 31 of the next following year	1 hour
