CITY OF TORONTO

BY-LAW 77-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Eglinton Avenue East and Eglinton Avenue West.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Eglinton Avenue West	North	Between a point 72.5 metres east of Castleknock Road and a point 44 metres further east	Anytime

- B. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Eglinton Avenue West	North	Between a point 85 metres east of Castle Knock Road and a point 12 metres further east	Anytime

C. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Eglinton Avenue West	North	Between a point 72.5 metres east of Castleknock Road and a point 44 metres further east	Anytime
Eglinton Avenue West	South	A point 16 metres west of Duncannon Drive and a point 17.5 metres further west	Anytime

D. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

Eglinton Avenue East	A point approximately 65 metres east of Old Forest Hill Road and the westerly limit of the Belt Line Bridge	Southerly Eastbound	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays	PTVs and Taxicabs

F. By inserting in Schedule XXII (Reserved Lanes For Designated Classes of Vehicles) in § 950-1321, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Times and/or Days)	(In Column 5 Designated Class of Vehicle)
Eglinton Avenue West	A point approximately 65 metres east of Old Forest Hill Road and the westerly limit of the Belt Line Bridge	Southerly Eastbound	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays	PTVs and Taxicabs

G. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Eglinton Avenue East	Chaplin Crescent and Avenue Road	40

H. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Eglinton Avenue West	Chaplin Crescent and Avenue Road	40
