CITY OF TORONTO

BY-LAW 92-2025

To authorize the entering into of an agreement for the provision of a municipal capital facility for affordable housing at 1886-1920 Eglinton Avenue West, Toronto.

Whereas section 252 of the City of Toronto Act, 2006 provides that the City may exempt from taxation for municipal and school purposes land or a portion of it on which municipal capital facilities are, or will be, located and an agreement for municipal capital facilities may allow for the lease, operation or maintenance of the facilities; and

Whereas paragraph 18 of subsection 2(1) of Ontario Regulation 598/06 prescribes municipal facilities used for affordable housing for the purpose of section 252 of the City of Toronto Act, 2006; and

Whereas subsection 7(1) of Ontario Regulation 598/06 requires that in respect of municipal facilities used for housing, that all the housing units fall within the definition of "affordable housing" as that term is defined in the Municipal Housing Facility By-law 713-2024; and

Whereas 1886 Eglinton West Ltd., CB Eglinton Properties Ltd., and Clifton Blake Bridge Fund V LP, by its general partner CB Fund V GP Inc. have agreed to provide affordable housing at the property currently known as 1886-1920 Eglinton Avenue West, Toronto; and

Whereas the portions of the Premises identified in Schedule A hereto are to be primarily used for affordable housing (the "Eligible Premises"); and

Whereas Council wishes to enter into an agreement with 1886 Eglinton West Ltd., CB Eglinton Properties Ltd., and Clifton Blake Bridge Fund V LP, by its general partner CB Fund V GP Inc. for the provision of municipal capital facilities for use as affordable housing at the Eligible Premises;

The Council of the City of Toronto enacts:

1. The City of Toronto is authorized to enter into an agreement under section 252 of the City of Toronto Act, 2006 with 1886 Eglinton West Ltd., CB Eglinton Properties Ltd., and Clifton Blake Bridge Fund V LP, by its general partner CB Fund V GP Inc. for the provision of affordable housing at the Eligible Premises, in accordance with Ontario Regulation 598/06 (the "Agreement").
