CITY OF TORONTO

BY-LAW 111-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Ambleside Avenue and Chartwell Road.

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ambleside Avenue	North	Aberlady Road and a point 20 metres east	Anytime
Ambleside Avenue	North	A point 100 metres east of Aberlady Road and Chartwell Road	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Chartwell Road	West	Ambleside Avenue and a point 30 metres north	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Chartwell Road	West	A point 60 metres north of Ambleside Avenue and a point 55 metres further north	8:00 a.m. to 5:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ambleside Avenue	South	Chartwell Road and a point 186 metres west	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Chartwell Road	East	Ambleside Avenue and a point 97 metres north of Castlebar Road	8:00 a.m. to 5:00 p.m., Mon. to Fri.

C. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Ambleside Avenue	North	A point 20 metres east of Aberlady Road and a point 80 metres further east	8:00 a.m. to 5:00 p.m., Mon. to Fri.	10 mins.
Chartwell Road	West	A point 115 metres north of Ambleside Avenue and a point 65 metres further north	8:00 a.m. to 5:00 p.m., Mon. to Fri.	10 mins.
