BY-LAW 132-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Raglan Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Raglan Avenue	East	A point 32.7 metres north of St. Clair Avenue West and a point 60.3 metres north of St. Clair Avenue West	Anytime

Raglan Avenue	West	A point 61.1 metres north of St. Clair Avenue West and a point 130 metres south of Maplewood Avenue	From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive
Raglan Avenue	West	A point 32.7 metres north of St. Clair Avenue West and a point 60.3 metres north of St. Clair Avenue West	Anytime

Raglan Avenue	West	A point 131.1 metres north of St. Clair Avenue West and a point 130 metres south of Maplewood Avenue	6:00 a.m. to 6:00 p.m., Mon. to Fri., from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	1 hour
