## **CITY OF TORONTO**

### **BY-LAW 191-2025**

**To amend City of Toronto Municipal Code Chapter 925, Permit Parking, in respect of 595 Bay Street, 304-316 Yonge Street, 14-40 Dundas Street West, 409-415 Yonge Street, 9 and 17 McGill Street, 180-200 Dundas Street West, 123 Edward Street, 65 Centre Street, 412-418 Church Street, and 79-81 Granby Street.**

The Council of the City of Toronto enacts:

1. City of Toronto Municipal Code Chapter 925, Permit Parking, is amended by inserting new Subsections C.14, C.15, C.16, C.17, C.18, C.19, C.20, C.21, C.22 and C.23 in § 925-4 as follows:

"C.14 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 595 Bay Street.

C.15 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 304-316 Yonge Street.

C.16 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 14-40 Dundas Street West.

C.17 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 409-415 Yonge Street.

C.18 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 9 and 17 McGill Street.

C.19 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 180-200 Dundas Street West.

C.20 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 123 Edward Street.

C.21 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 65 Centre Street.

C.22 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 412-418 Church Street.

C.23 Despite anything in this chapter to the contrary, the General Manager will not accept applications for a permit from residents of, visitors to or tradespersons at the development located at 79-81 Granby Street."
