BY-LAW 220-2025

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, and City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Harbourview Crescent.

Whereas City of Toronto Council on January 30, 31 and February 1, 2001 adopted Report No. 1, Clause No. 10 of the West Community Council, wherein it was recommended that on-street parking permits be introduced to the outer perimeter of Harbourview Crescent starting at a point 90.0 metres east of Fleeceline Road, and terminating on the west side of the Fleeceline Road/Harbourview Crescent intersection, excluding the west side of the outer perimeter of Harbourview Crescent with parking prohibited on the inside perimeter and the west side outer perimeter of Harbourview Crescent; and

Whereas City of Toronto Council on February 1, 2001 enacted By-law 90-2001, being a by-law "To amend the Municipal Code of the former City of Etobicoke with respect to Parking Permits - Chapter 183, Article V" which inadvertently did not include the exclusion of permit parking on the west side of the outer perimeter of Harbourview Crescent as recommended in amended Recommendation 1; and

Whereas City of Toronto Council on February 1, 2001 enacted By-law 89-2001, being a by-law "To amend the Municipal Code of the former City of Etobicoke with respect to Traffic - Chapter 240, Article I" which inadvertently did not incorporate the amendments made at Council to prohibit parking on the west side of the outer perimeter of Harbourview Crescent as recommended in amended Recommendation 3; and

Whereas pursuant to Section 169-5.2B of City of Toronto Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors, to update the by-laws to refer to the current statute, City official title, administrative unit and Municipal Code provision and to repeal by-laws of the former municipalities that have been superseded by provisions in the Municipal Code or as a result of an administrative reorganization;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:
