## **CITY OF TORONTO**

### **BY-LAW 235-2025**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Cherry Street and Eastern Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Front Street East	North	Cherry Street and a point 30.5 metres west	Anytime

B. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Cherry Street	West	A point 44 metres south of Mill Street and a point 33 metres north of Front Street East	Anytime
Eastern Avenue	Both	Cherry Street and Front Street East	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Cherry Street	West	A point 44 metres south of Mill Street and Front Street East	Anytime
Cherry Street	West	Front Street East and a point 53 metres north	Anytime
Eastern Avenue	North	Cherry Street and Front Street East	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Eastern Avenue	South	Front Street East and a point 33 metres west of Cherry Street	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Eastern Avenue	South	Cherry Street and a point 33 metres west	Anytime
Front Street East	North	Cherry Street and a point 51.5 metres west	Anytime
