BY-LAW 638-2025

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Villiers Street.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VIII (Bus Parking Zones) in § 950-1307, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Times and/or Days) | (From Column 5 Maximum Period Permitted) |
|-----------------------------------|----------------------------|---|---|---|
| Villiers Street (north branch) | North | A point 229.5 metres east of Ookwemin Street and a point 65 metres further east | Anytime | 24 hours |

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-------------------------------|----------------------------|---|---|
| Villiers Street | South | Munition Street and a point 36 metres west | Anytime |

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|--------------------------------|----------------------------|---|---|
| Villiers Street (north branch) | North | Ookwemin Street and a point 144 metres east of Munition Street | Anytime |
| Villiers Street (north branch) | South | Ookwemin Street and a point 144 metres east of Munition Street | Anytime |
| Villiers Street (south branch) | South | Ookwemin Street and a point 29 metres east of Munition Street | Anytime |
| Villiers Street (south branch) | South | Ookwemin Street and a point 36 metres east | Anytime |
| Villiers Street (south branch) | South | A point 116 metres east of Ookwemin Street and a point 21.5 metres further east | Anytime |
| Villiers Street (south branch) | South | A point 182.5 metres east of Ookwemin Street and a point 54.5 further east | Anytime |

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|--------------------------------|--------------------------|--|---|
| Villiers Street (north branch) | South | A point 15 metres east of Munition Street and a point 15 metres further east | Anytime |
| Villiers Street (south branch) | South | Munition Street and a point 15 metres west | Anytime |

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Prohibited Times and/or Days) |
|-----------------------------------|----------------------------|------------------------------------|---|
| Villiers Street (north branch) | Both | Ookwemin Street and Don Roadway | Anytime |

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Prohibited Times and/or Days) |
|-----------------------------------|--------------------------|--|---|
| Villiers Street (north branch) | North | A point 75 metres east of Munition Street and a point 69 metres further east | Anytime |
| Villiers Street (north branch) | South | Ookwemin Street and Don Roadway | Anytime |
